1. SOME BASIC CONCEPTS

- **1.1.Service** our Internet service available at the domain https://veganstock.eu/.
- 1.2. Your personal data all information about you that allows us to identify you directly (e.g. your e-mail address) and indirectly (e.g. your activity on the site). For more information about what your personal data we process, see Chapter 3.
- **1.3. Data Administrator** the administrator of your data processed within the Service is us: Vegan Stock sp. z o.o. based in Szaflary (ul. Zakopiańska 35A, 34-424 Szaflary, Poland).
- 1.4.RODO Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and RODO imposes specific obligations on entities that perform operations on personal data (either on their own behalf or on behalf of another entity). It guarantees the exercise of your data protection rights you can read more about this in Chapter 11.

2. WHY DO WE PROCESS YOUR DATA?

WE WILL USE YOUR DATA FOR A VARIETY OF PURPOSES, BUT ONLY WHEN JUSTIFIED

- **2.1.**We process your data because:
 - **2.1.1.** This is necessary to enable you to use the Service. This allows you to browse the available content and to contact us via the contact form;
 - **2.1.2.** We want to know your opinion about us. We may contact you with a request to participate in a satisfaction survey;
 - **2.1.3.** we analyze your and other users' activities to **develop our services** and **provide convenience** of the Service;
 - **2.1.4.** We want to ensure safe use of the Service and protect our rights and those of our users.
- **2.2.** In some cases, we may use the collected data to assert or defend against our claims.
- **2.3.** We may also use your data for our own marketing we describe the principles of processing in this regard in Section 8.
- **2.4.** If you visit our profiles on social networks, we may use your data to inform you about our activities and to promote various events, services and products we describe the principles of processing in this regard in Section 9.

3. WHAT DATA DO WE PROCESS?

WE COLLECT YOUR DATA ONLY FOR LEGITIMATE PURPOSES

3.1. Communication with us:

- **3.1.1.** We process the data you provide to us in the contact form;
- **3.1.2.** we collect any information you choose to provide when you call or email us;
- **3.1.3.** we may send you surveys to check your satisfaction with our services, and we process the information you provide to us as part of your responses.
- **3.2. Information collected through cookies and other similar technologies** this is information about your device, your location, login data and your activity on the Service. We write more about our processing of cookie data <u>in Chapter 10.</u>
- **3.3. Data collected when signing up for the newsletter** we process the email address you provide to us in the newsletter sign-up form.
- **3.4. Data provided when visiting profiles on social networks** we process those data that you make public on a particular social network.
- **3.5.** With the personal data we collect from you on the Service, we may combine data obtained from third parties in the form of technical and usage-based information that we have obtained from analytics providers (Google Tag Manager, Google Analytics, Pixel Facebook, LinkedIn Insight Tag)

When using certain services or filling out certain forms, you may provide **additional personal data**. Providing this data is voluntary, but necessary to use the particular service. We will inform you of this by, for example, marking mandatory fields.

DO WE OBTAIN DATA FROM CHILDREN?

Our services are not directed to persons under 16 years of age and we do not knowingly obtain information about them. If we find that a person under the age of 16 has provided us with personal information, we will delete it immediately.

4. HOW LONG DO WE KEEP YOUR DATA?

WE DO NOT KEEP YOUR DATA LONGER THAN NECESSARY

PURPOSES AND DURATION OF PERSONAL DATA PROCESSING

- **4.1.** The length of time we process your data depends on the purposes for which we use it and the legal basis for processing it. To determine the appropriate retention and deletion periods for personal data, we also took into account the scope, amount, nature and sensitivity of the data, as well as the potential risk of harm.
- **4.2.** We will process your data for as long as necessary to fulfill the purposes for which we collected them. We detail the purposes and periods of processing of your data in <u>Appendix to the Privacy Policy.</u>

DELETION OF PERSONAL DATA

- **4.3.** We will delete your data irretrievably only when it is no longer needed for any processing purpose.
- **4.4.** We may delete some of your data earlier than others. This may happen when we no longer need them for one processing purpose, but they are still necessary for another purpose.

5. WITH TO WHOM DO WE SHARE YOUR DATA?

WE TRANSFER YOUR DATA TO OTHER ENTITIES WHEN WE HAVE SUCH A LEGAL OBLIGATION

- **5.1.Law enforcement, regulatory authorities and others** we may disclose selected information about you to competent authorities or third parties who make such a request. We will do this in accordance with the law.
- **5.2.** Marketing and analytics providers to improve our Services, we sometimes share information about you with providers such as Hotjar. They help us analyze how users use the Service. For more information, see Section 10.

TECHNICAL AND ORGANIZATIONAL SAFEGUARDS

- **7.1.**We store all the information we receive about you on properly secured servers.
- **7.2.** We constantly assess the security level of our network, and monitor internal regulations and procedures. This allows us to:
 - **7.2.1.** protect data from accidental or unlawful loss, unauthorized access or disclosure:
 - **7.2.2.** identify foreseeable risks to the security of our network;
 - **7.2.3.** minimize security risks, including through risk assessment and regular testing.
- **7.3.** All payment-related data is encrypted using SSL technology.

THIRD PARTIES PROVIDING SERVICES TO US

- **7.4.** To maintain and provide certain solutions related to our services, we use third-party providers (processors). We conduct audits of these providers and require them to ensure the security of your data and to process it in accordance with the law.
- **7.5.** As part of our cooperation, we stipulate that these suppliers may process personal data only for the purposes expressly indicated and in accordance with our instructions.

RODO GUARANTEES YOU SPECIFIC RIGHTS AND YOU CAN EXERCISE THEM

WHAT RIGHTS YOU HAVE

TYPE	DESCRIPTION
Right of access to data	You can check whether we process your personal data, and if so, you can get a copy of your data.
Right of rectification	You may request correction of incomplete, false or outdated data. In fulfilling your request, in some cases we will need to verify the accuracy of the new data you provide to us.
Right to restrict processing	 You can ask us to stop processing your data when: You want us to check the accuracy of the data; You consider our processing of your data to be unlawful; we no longer need your data, but they are needed by you to pursue or defend against claims; you file an objection to the processing - in this case we will verify whether we have overriding grounds to continue processing your data.
Right to object to processing	Applies when we process your data on the basis of legitimate interests (ours or those of third parties). You can object on grounds related to your particular situation when you believe the processing affects your rights or freedoms. Sometimes it may be that we have legitimate grounds for processing your data that override your rights and freedoms (e.g., the need to ensure the security of the Service and prevent fraud). However, you can always object to processing for direct marketing purposes.

The right to delete data	You can request deletion of your data if it is no longer necessary for the purposes for which it was collected. You can also request deletion of your data if: • you withdraw your consent and we have no other legal basis for processing; • you file an effective objection to the processing; • your personal data was processed illegally; • your data must be deleted by law. Please note that in some cases we are obliged to process your data on the basis of applicable regulations and we will not be able to fulfill your request.
Right to data portability	In exercising this right, we will provide you or a third party you designate with your personal data. However, you have this right only to the extent of data processed on the basis of consent or in the performance of a contract, and the processing is carried out by automated means (in computer systems).
Withdrawal of consent	If you have given us consent to process some of your data, you have the right to withdraw that consent at any time. Withdrawal of consent does not affect the lawfulness of the processing that was carried out before its withdrawal.

- 11.3. We strive to respond to your requests within one month. If your request is particularly complicated or we have received several requests from you, it may take us longer to recognize your request. If this is the case, we will inform you that it will take longer, and we will keep you updated on the status of your request.
